MANDATORY STUDIO UNIFORM

ALL FEMALE DANCERS MUST WEAR A LEOTARD & TIGHTS FOR ALL CLASSES

BALLET SKIRT & SHORTS ARE ACCEPTABLE FOR SOME CLASSES (worn over tights & leotard)

HAIR IN A PONYTAIL OR BUN / PROPER SHOES FOR THE STYLE OF CLASS

ALL DANCERS ABSOLUTELY NO: PANTS, STREET CLOTHES, STREET SHOES, BAGGY CLOTHING ALLOWED!

ALL MALE DANCERS: GYM SHORTS / T-SHIRT / PROPER STYLE SHOES (usually in black)

There will be a \$10.00 late fee added to your account for all late tuition payments.

AFTER REGISTRTRION - ALL PAYMENTS ARE DUE BY THE 15th OF: OCTOBER/DECEMBER/FEBRUARY/APRIL

- Any account that has not made a tuition payment by the first day of the next month will be removed from the class roster
- Dancer may NOT skip months or payments
- There will be a \$35.00 fee added to your account for all returned checks
- THERE ARE ABSOLUTELY NO REFUNDS/EXCHANGES ON TUITION PAYMENTS OR DEPOSITS
- Graceful Moves Dance has the right to change classes, pricing, dates, charges, and fees without notice.
- NO REFUNDS, RETURNS OR EXCHANGES ON COSTUMES OR CLASS PAYMENTS TO STUDENTS WHO HAVE DISCONTINUED THEIR CLASSES OR HAVE NOT BEEN COMPLIANT WITH THE STUDIO RULES. THE STUDIO HAS THE RIGHT TO RETAIN ALL PAYMENTS & COSTUMES.
- If you choose to discontinue your class(es), YOU MUST NOTIFY THE STUDIO BEFORE THE BEGINNING OF YOUR NEXT BILLING PERIOD. You will be billed for that full billing period no matter when you quit. There are ABSOLUTELY no refunds on class payments when you choose to quit your dance class(es).
